"He did it all," she said, from the time he served as a police Explorer to Chief of Police. "He lived up to

e his own convictions."

Boys and Girls Clubs Board President Mike Schaub, who served as master of ceremonies at the event, said Romero "came to the board meetings and asked the tough questions."

Schaub said one of the biggest gifts Romero gave him was when he visited him the last time in the hospital with his son Jake.

"He said 'Jake, I need to tell you something," Schaub said. "'Jake, listen to your father because he loves you."

"He's the kind of guy... that did so many things for others," Schaub added.

Romero, who graduated from Ganesha High School in Pomona and received a bachelor's degree from the University of La Verne, also held a master's degree from Boston University.

He served his entire career in law enforcement and during his career headed all three divisions of the police department – patrol, administrative and detective bureau.

Youth of the Year

Earlier in the evening, Asusena Valdez, 18, this year's Boys and Girls Clubs "Youth of the Year," told nearly 300 guests that she decided during her five

years as a member of the club that by continuing her education, she could "control my own future."

Today, after completing the club's college-bound program with 21 other participants, she is studying psychology at Citrus College in Covina. She is also working part time but still returning as a volunteer at the Boys and Girls Clubs.

ALL FIVE BALLOT MEASURES FAIL Rothman, Lantz re-elected as Nolte, Martin win seats on Pomona council

Pomona Mayor Elliott Rothman was returned to office for a second fouryear term in this month's election and Councilmember Paula Lantz held onto her seat for another four years, although Councilmembers Danielle Soto and Steve Atchley lost to challengers John Nolte and Debra Martin.

All five measures on the Pomona ballot failed. One measure, Measure X, which would have imposed a library parcel tax, received nearly 60 percent of the vote but required a two-thirds majority to be approved.

The four other measures included Measure T, which would have required councilmembers to be elected by the entire **Election results... pg. 4**

Él sirvió su carrera entera en guardar el orden público y en la aplicación de la ley y encabezo las tres divisiones del departamento de policía - la de patrulleros, la administrativa y la oficina de detectives.

Esa misma noche también se le dio reconocimiento a la joven Asusena Valdez de 18 años y la nombraron la "Joven del Año" de los Clubs de Niños y Niñas. Ella le dijo a las casi 300 personas presentes que durante los cinco años que ella fue miembro del club habia aprendido que el control de su futuro dependia en que ella continuará sus estudios.

Pomona's Park West High School students working on trip to 9/11 memorial in New York

Students at Pomona's Park West High School are "in a New York state of mind" and are trying to raise \$35,000 to enable 20 students to fly to New York to commemorate the "Heroes of 9/11."

The program was designed by Nancy Fegert, a social studies teacher at Park West, after her American government class prepared a presentation for the school explaining terrorism and outlining the events of Sept. 11, 2001.

The New York trip – which will include a visit to the 9/11 memorial – was suggested by a visiting parent following the presentation, who added that her employer would be willing to be a contributing sponsor.


Park West's student body is comprised of 89 percent Hispanic students, 55 percent of whom are English learners and 82 percent qualify for free or reduced lunches. The cost of the trip will be

\$1,790 per student.

NEW LA VERNE VETERANS MEMORIAL -- Veterans Day in La Verne last Monday attracted more than 700 residents and visitors -- far more than organizers anticipated -- to participate in the dedication of a new \$158,000 La Verne Veterans Memorial at Bonita and Wheeler Avenues. La Verne Mayor Don Kendrick called the memorial "a dream becoming a reality," adding that there is no requirement that names included in paving stones placed at the memorial be La Verne residents. "The memorial is for all, not just a few," Kendrick said. He said there were two goals for the project -- to honor those who served and to create a memorial that all would be proud of. "This is your memorial. We hope you will be as proud of it as we are," he said. While Navy Reserve Lt. Shawn Harden pointed out this was the nation's first Veterans Day without a living veteran from World War I, last week's ceremony attracted veterans literally from every war and conflict since World War I. He thanked those present for their service. "Veterans, you have done your duty," he said. Guest speaker Lawrence Gonzales, Undersecretary of Operations, California Department of Veterans affairs, represented Gov. Brown at the event. He said more than two million veterans live in California. 

Pomona Host Lions award \$4,900 in mini-grants to teachers

The Pomona Host Lions Club recently presented \$4,900 in minigrants for instructional enrichment to 20 teachers from the Pomona Unified School District, bringing the club's total over the past nine years to \$45,000.

"Each of you gives tremendous time beyond the school day and contributes large amounts of your own money beyond school funding to insure a quality education for your students," Lions President Barbara Smith told the teachers at a recent awards ceremony in Pomona. "It is our club's pleasure to enable you to purchase items to enrich your lessons without your having to dip even more into your own pockets."

Lion Morgan Brown, who is also executive director for the Associated Pomona Teachers (APT), is chair of the Lions mini-grant program.

Both Brown and Pomona Unified School District Board member Frank Guzman, also a Lions Club member, shared their appreciation and congratulations with the teachers. Mini-grants of up to \$250 are awarded to individuals, and grants up to \$500 are awarded to "teams."

This year, 14 individuals and three teams received awards.

Members of the Pomona Host Lions Club went back to the first grade in Pomona this month to give American flags to the first graders in honor of Veterans Day.





Residents, students and officials participate in grand opening of new 'school based' free clinic in La Puente

Several hundred residents and elementary school students from southeast La Puente, Mariachis and school district officials were on hand last week for the grand opening of the new East Valley Community Health Center located on the campus of La Puente's Villacorta Elementary School.

East Valley operates two additional clinics, one in Pomona at 680 Fairplex Drive (at Mission Boulevard), and another in West Covina. The Pomona office is slated for relocation to a new facility in the old Stater Brothers market at 1555 S. Garey Avenue, Pomona.

Construction on that 24,000 square foot facility is slated to begin next month with completion scheduled late next year.

Alicia Mardini, CEO of East Valley, said the La Puente location has been operating on a limited 20 hour a week basis pending licensing, working under the West Covina clinic management, but will be fully operational beginning Monday.

The school based free clinic about a 2,400 square foot facility will employ about 10 people and includes five exam rooms, staff offices and a dispensary.

Pomona police receive \$246,000 in traffic safety grants

The Pomona Police Department has received two grants from the California Office of Traffic Safety for programs to help prevent traffic deaths and injuries, according to a police department news release.

A \$120,000 grant will provide a year-long special enforcement and public awareness program to prevent traffic collisions.

"While traffic deaths from all causes declined by nearly 39 percent between 2006 and 2010 in California, state and federal officials anticipate that figures will show a slight rise in 2011," the news release said. "Driving under the influence deaths remain the largest sector, at nearly 30 percent of traffic fatalities."

The program will include special DUI and drugged driving training, DUI saturation points, motorcycle safety enforcement, distracted driving enforcement and stakeout operations to observe the "worst of the worst" repeat DUI offender probationers with suspended or revoked driver licenses.

In a related program, the police department received a \$126,000 grant for an anti-DUI program.

The special DUI checkpoint grant will assist in efforts to reduce the number of persons killed and injured in alcohol and other drug related collisions.

The program will target impaired driving offenders and will educate the public on the dangers of impaired driving through the use of DUI and driver's license checkpoints.

In 2010, 791 people were killed and more than 24,000 injured in alcohol and drug-impaired crashes in California.




